Sealed bids in TWO parts are invited for supply of Safety shoes on FOR destination basis from the reputed Manufacturers / Authorized Dealers / suppliers with proven track record of having supplied the similar materials. The materials are required for Sharavathy Hydro Electric Project, KPCL., Jogfalls.
2. The Bidder shall have the following Pre-Qualifying requirements (PQR).
 - a. The bidder shall be a regular Manufacturer/Authorized dealer/Supplier as indicated in the Bid Notification and should have successfully supplied the Safety shoes for at least two reputed organizations. In proof of the above, Purchase Order copies issued by the utilities/ user organizations have to be furnished as a proof of experience. Dealers should furnish the dealership certificate.
 - b. The bidder shall have adequate resource to affect the supply of material expeditiously within the time specified.
 - c. The Bidder shall have a minimum annual turnover of Rs.10.00 lakhs during last two financial years. In proof Annual Report / turn over certificates duly certified by Chartered Accountant shall be furnished.
 - d. The bid documents will not be accepted of such of the manufacturers or dealers whose contracts have been terminated/foreclosed in KPCL or else where during last 10 years and also those who do not meet the above qualifying requirements.
 - e. Bidders should furnish PAN & TIN numbers compulsory.
3.
